### **David L. Lawrence Convention Center**

- A. Ratification of a contract with H.E. Neumann Company in an amount of \$29,700 for drain pipe emergency replacement in the chilled water plant.
- B. Authorization to approve a purchase order with V-Systems in an amount of \$5,600 for the purchase of two replacement bladders for the expansion tanks in the chilled water plant.
