SPORTS EVENT FUNDING PROGRAM

2025 Round Two Grant Application Announcement

PITTSBURGH, PA: The Sports & Exhibition Authority of Pittsburgh and Allegheny County (SEA) announces its second 2025 Sports Event Funding (SEF) Program application submission period. Applications will be accepted from Sunday, June 15, 2025, through Tuesday, July 15, 2025, at 3:00 PM, via the SEA grant portal. The SEA grant portal can be found at: <https://sea.fluxx.io/>.

The SEF Program provides financial assistance to support major sporting events that provide significant economic impact to Allegheny County. Qualifying events include athletic or Esports events, whether professional or amateur, that are regulated and sanctioned by a regional, national, or international organization. Funding up to \$75,000 may be awarded in the form of a grant or loan. The event must take place sixty (60) days after the application period ends and within two years of the application date.

Submitted applications will be evaluated on the following factors:

- Impact of the competitive sporting event on the Allegheny County economy
- Potential to attract visitors from outside of the immediate area resulting in overnight hotel stays and room blocks
- Potential to provide high-value exposure to the region via traditional and social media vehicles
- Financial need and level of private investment detailed in a comprehensive budget
- Event quality, readiness, and likelihood of success based on an operational plan including specifics on event facility locations
- Diversity, accessibility, and environmental sustainability

Submitted applications will first be evaluated by the SEA Sports Commission, a committee of the SEA. Applications recommended by the SEA Sports Commission will then be considered for funding by the SEA Board.

Since its inception, the SEF Program has awarded approximately \$3.85 million across 76 grants to 37 different organizations. These grants have supported events showcasing over 25 different sports. The funded events have generated an estimated \$307 million in direct spending within Allegheny County.
